RULES, REGULATIONS, DRESS CODE & CODE OF CONDUCT

1. NO PLAYER SHALL BE ALLOWED TO PLAY HIS/HER GAME IF THEY HAVE NOT PAYED THEIR ENTRY FEES BEFORE THEIR FIRST GAME.
2. IN THE INITIAL ROUNDS OF ALL THE CATEGORIES, THE MARKER OR A DESIGNATED PERSON SHALL BE THE REFEREE OF THE GAMES PLAYED.
3. IN THE LADIES CATEGORY, THERE SHALL BE A MAXIMUM OF 3 FOUL AND MISSES. ALL FRAMES SHALL BE OF A MAXIMUM OF 30 MINUTES DURATION AFTER WHICH THE FRAME SHALL BE AWARDED TO THE PERSON WHO IS LEADING.
4. ALL PARTICIPANTS ARE REQUESTED TO MAINTAIN GOOD SPORTSMAN SPIRIT AND CONDUCT. IN THE INTEREST OF THE TOURNAMENT & THE GAME, ANY PARTICIPANT/INDIVIDUAL FOUND TO BE MISBEHAVING, BEHAVING UN-GENTLEMANLY OR CONDUCTING HIMSELF/HERSELF IN A MANNER UNBECOMING OF THE STATUS AND PRESTIGE OF THE CLUB AS WELL AS THE GAME, SHALL BE FORTHWITH SCRACHED FROM THE **TOURNAMENT AND SHALL NOT BE ALLOWED TO ENTER THE CLUB PREMISES.** THE MC MAY TAKE SUCH FURTHER ACTION AS IT MAY DECIDE IN ITS DISCRETION AS THE CIRCUMSTANCES OF THE CASE MAY WARRANT' MR.MANAV PANCHAL/MR ADITYA KAPOOR/ MR RAJEEV SHARMA ARE PART OF THE TOURNAMENT COMMITTEE AND WILL REPRESENT THE MALABAR HILL CLUB AND SUPERVISE THE DAY TO DAY PROCEEDINGS.
5. **DRESS CODE:** NO CHAPPALS,SANDALS, JEANS, T'SHIRTS OF ANY KIND SHALL BE ALLOWED. NORMAL FORMAL SMART CASUALS SUCH AS SHIRT, TROUSERS, FORMAL SHOES & SOCKS SHALL BE PERMITTED.
6. ALL PARTICIPANTS MUST BE PRESENT FOR THEIR MATCHES WELL IN TIME FOR THEIR MATCHES. ANYONE REPORTING LATE UP TO 15 MINUTES BEFORE THE SCHEDULED TIME SHALLBE PENALISED BY 1 FRAME IN SNOOKER AND BILLIARDS, BY 50 POINTS IN THE TIME FORMAT BILLIARDS. IF A PERSON REPORTS MORE THAN 30 MINUTES LATE FOR HIS MATCH HE/SHE SHALL FORFEIT HIS/HER MATCH TO THEIR OPPONENT UNLESS BY

MUTUAL CONSENT OR THE MANAGING COMMITTEE/TOURNAMENT DECISION BEING OTHERWISE.

7. THE MANAGING COMMITTEE/TOURNAMENT COMMITTEE DECISION SHALL BE FINAL AND BINDING ON ALL MATTERS. ANY PERSON DESIRING TO MAKE A COMPLAINT MAY DO SO BY WRITING A WRITTEN COMPLAINT ALONG WITH A PROTEST FEE OF RS.1000/- WHICH SHALL BE RETURNED IF HIS/HER PROTEST IS UPHELD. IN CASE OF THE PROTEST BEING OVERRULED, THE RS.1000/- SHALL BE FORFEITED.
